Discussion around Previous AGM Minutes:

- MV (OEC) requested minutes of previous AGM, as the normal process he was looking forward to receiving feedback today on things raised in last AGM (e.g. Audible Adhaan)
- RD recommended a list of action items be provided , and a possible follow up meeting?
- Boeta Achmat enquired whether someone can work on that during the AGM and we revert back to the matter
- KS indicated that they are not available because the Secretary is not here
- Decision that the agenda item stand over for a short while and obtain the minutes and raise later in the meeting

SMS – Imaamat report

- Masjid must be the heart & soul of the community
- Advised on all activity taking the placing in the masjid
 - o Classes
 - Events
 - Sessions
 - o Icons
 - o Ramadhaan
 - Stats of Imaamat work
- Question from the AS is SMS full time or half?
 - o KS we are in discussions to appoint someone to second SMS
 - Sharief Amien

 recommended an office for the SMS at the Masjid (better than visiting at home)
 - KS replied that we are almost at stage of getting plans approved, but difficult to get permissions for extensions. The following was discussed:
 - Classroom / office for SMS
 - Move kitchen to outside due to disruption, incl store room
 - Costs to be revised due to change in plan kitchen would have a different finish, plumbing, electrical
 - Will be done via council, above board, but will be quietly done so as to avoid objection
- ABL Noted that parking is a problem, and enquired about a double storey for caretaker unit
 - o KS advised about regulations relating to building against a boundary wall

- Question audible Adhaan
 - o KS agreement that we will not have an audible Adhaan
 - o RD do not want to jeopardise other areas by creating. Look at the bigger picture
 - From the audience (Prof.) we should not abandon the idea and should seek relief from restrictions on Eid's and during Ramadhaan
 - Nazreen Bawa Reminded that we had to compromise audible Adhaan when signing title deed
- Shafiq Gamiet asked what is the % of Muslims in Pinelands?
 - o RD could be 1000+ families
- MV (OEC) brought up the fact that the ghatam in Ramadhaan is split (in & out of Solaah) requested that we should do survey to community before next Ramadhaan
 - KS we have looked at this, and revisit every Ramadhaan. This was decided to keep it this way in order to maintain attendance levels
 - Decision that we will consider the survey
